1. CALL TO ORDER

The meeting was called to order by President Collins at 7:00 p.m.

2. ROLL CALL

4. APPROVAL OF PREVIOUS MEETING MINUTES

Motion was made by Herbold, seconded by Bubke to approve the October minutes. All voted aye, motion carried.

5. SUMMARY LIST OF BILLS

An explanation of invoices was sent to the Board before the meeting. Motion was brought by Herbold, seconded by Plendl, to approve listed bills in the amounts of \$139,070.74 from the general fund, \$63,978.39 from schoolhouse, \$45,204.07 from lunch fund, \$512.12 Pierson activity fund and \$6,668.84 from the Kingsley activity fund. All voted aye, motion carried.

6. FINANCIAL REPORT

October financials increase as we receive the quarterly property taxes, Federal and State reimbursements. Mr. Bailey and I worked with Iowa School Finance Information Services on a 5 year financial projection model. Nolte, Corman & Johnson completed the FY23 audit on October 26th. We are waiting for a draft copy for review. MidStates Bank's October interest rate for Kingsley-Pierson School is 4.54%. The Plymouth County auditor confirmed the Physical Plant and Equipment Levy (PPEL) passed on November 7th by the voters with a majority percentage of 53.33%. Preliminary results by county, Plymouth 56.36% yes, 43.64% no. Cherokee 50% yes, 50% no. Woodbury 46.24% yes, 53.76% no. The final canvas results will be provided by the auditor on November 21st. On the School Board election of the three at large members, preliminary results show Phil Herbold, Curtis Motz and Lindsay Smit being elected. After we receive the final canvas votes, the members will be sworn in at the December Board meeting. Motion by Plendl, seconded by Herbold to approve the financial report. All voted aye, motion carried.
