### 1. CALL TO ORDER

The meeting was called to order by President Collins at 7:00 p.m.

## 2. ROLL CALL

Present Members: Plendl, Smit, Motz and Herbold.

### 3. AGENDA

Motion was brought by Herbold, seconded by Motz to approve the agenda. All voted aye, motion carried.

### 4. **OPEN FORUM**

The following visitors addressed the board with concerns or comments. President Collins called nine citizens of the public to speak at the open forum since they signed in before the meeting. ## 5. APPROVAL OF PREVIOUS MEETING MINUTES

Motion was made by Herbold, seconded by Plendl to approve the February minutes. All voted aye, motion carried.

## 6. SUMMARY LIST OF BILLS

An explanation of invoices was sent to the Board before the meeting. Motion by Herbold, seconded by Motz, to approve listed bills in the amounts of \$74,691.10, from the general fund, \$100,008.44 from schoolhouse, \$40,012.98 from lunch fund and \$8,370.56 from the Kingsley activity fund. All voted aye, motion carried.

## 7. FINANCIAL REPORT

February, we are eight months into the fiscal year and 67% of the budget. Revenue is down compared to January. March revenue will reflect the property tax income from the counties. Thank you to Mrs. Ploeger for writing an agricultural grant for library books. The school received \$200 from the Iowa Agriculture Literacy foundation. Thank you to Dr. Kempers, Mrs. Spooner and Mrs. Kate Goodwin for their hard work in receiving \$40,000 for STEM Businesses engaging students and teachers. This is a partnership with local businesses and the school to develop a work-based learning model. Expenses are holding steady at 63.9%. MidStates offered a 4.56% interest rate on all MidStates bank accounts

for the month of February. This is .50 basis points under the ISJIT rate of 5.06%. FY2023 was completed in October 2023, we are awaiting the final from our auditors. Since they will not meet the March  $31^{st}$  deadline with the State, the firm will be sending out and extension letter for the school to file with the State Auditor.

Motion by Herbold, seconded by Plendl to approved the 2024-2025 Budget Guarantee Resolution stating <u>"Resolved, that the Board of Directors of Kingsley-Pierson Community</u> School District, will levy property tax for fiscal year 2024-2025 for the regular program budget adjustment as allowed under section 257.14, Code of Iowa." All in favor, motion carried.

### 2024-2025 Proposed Budget Review:

Mrs. Schweitzberger proposed three levy rates for the 24/25 Budget review. These rates included 11.00206, 11.90008 and 10.79810. Motion by Herbold, seconded by Plendl to approved the proposed tax levy rate of 10.79810 to be published. All in favor, motion carried.

Motion by Herbold, seconded by Plendl to accept Ross Johnson's resignation from the MS Math position. All in favor, motion carried. Motion by Plendl, seconded by Motz to accept the resignation of Jackie Lammers as JH Basketball and JH Wrestling Cheer coach. All in favor, motion carried. Motion by Herbold, seconded by Smit to accept the resignation of Amanda Seuntjens as HS Wrestling Cheer coach. All in favor, motion carried.

Motion by Herbold, seconded by Plendl to approve the renewal of Delta Dental 24/25 insurance. Delta Dental is an employee paid benefit. Single coverage increased 6%. All in favor, motion carried.

Motion by Plendl, seconded by Motz to approve the renewal of the ISEBA Life/AD&D/LTD 24/25 insurance renewal. Life/AD&D coverage is an employer paid benefit. LTD coverage is a employee paid benefit. There is no change in rates. All in favor, motion carried.

## Mercer Health Insurance Renewal:

Motion by Plendl, seconded by Smit to approve the 24/25 health insurance/vision insurance renewal. Single health insurance increased by 2.91%. There are currently 43 employees on the single plan. All in favor, motion carried.

The Education Legislative bills passed out of the House include AEA Bill and Teacher Salary increases. The House proposed a bill for teacher salary minimums for 24-25 school year \$47,500. Teacher salary minimums for 26-27 school year \$50,000. There is a bill for education support personnel to \$15 p/hr minimum. There is a proposal for 22 million supplements for school districts, school safety bill and open enrollment transportation.
