

MASTER AGREEMENT

between

and

ARTICLE 1

GENERAL CONTRACT PROVISIONS

A. DEFINITIONS

1. The term “District”, as used in this Agreement, shall mean the Kingsley-Pierson Community School District.
2. The term “Employee”, as used in this Agreement, shall mean all professional employees represented by this Association in the bargaining unit as defined and certified by the Public Employment Relations Board.
3. Included in this bargaining unit shall be all regular and part-time professional employees including: Classroom Teachers K-12, Librarian, Special Teachers, Chapter I Teachers and Guidance Counselor.

ARTICLE 2

WAGES

A. METHOD OF PAYMENT

1. Pay Periods

Each employee shall be paid in twelve (12) equal installments on the 20th of each month.

2. Exception

When a pay date falls on or during a school holiday, vacation, or weekend, employees shall receive their paychecks on the last, previous working day.

3. Summer Checks

Summer checks shall be direct deposited or mailed to the address designated by the employee unless the employee requests that he or she be allowed to pick up his or her check in person.

Staff who have completed 12 years of experience in education are to receive a salary of at least \$60,000.

C. SALARY INCREASE

For the 2024-25 school year, each full-time employee will receive \$125/per total years of service. All staff not at the minimums, set by the state, will be brought up to said minimums proportionately for their FTE. Staff on BA+30 and higher will receive all but \$1,500 credit for their educational lanes achieved in 2024-25 and the remaining \$1,500 in 2025-26. Staff on BA+15 will receive \$1,500, the first year only. Staff may advance lanes for achieving the agreed

upon graduate credit hours. Part-time employees will receive an increased amount proportionate to their full time equivalency.

ARTICLE 3

EXTRA-CURRICULAR PAY

A. EXTRA-CURRICULAR ACTIVITIES

Employees assigned extra-curricular activities shall be compensated in accordance with the Extra-Curricular Salary Schedule below. Prior to assigning employees to the extra-curricular duties listed in the Extra-Curricular Salary Schedule, the District shall seek volunteers from the bargaining unit to fill the position. If the positions cannot be filled on a voluntary basis, the District reserves the right to assign Extra-Curricular duties.
