#### 6. FINANCIAL REPORT

For the April review, we are ten months into the fiscal year and 83% of the budget. Revenue is at 83.2% of the budget and expenditures at 71.6%. MidStates offered a 4.56% interest rate on all MidStates bank accounts for the month of April. This is .50 basis points under the ISJIT rate of 5.06%. Thank you for the donations received this year. In April, Kingsley-Pierson School received donations from the Panther Ball of \$9,771.14 and the Dwelling for \$1,402. Thank you to the KP Music Boosters for their donations this year of \$7,186.52. May is open enrollment month for employee's benefits for health, dental, vision and flex accounts.
