1. CALL TO ORDER

Motion by Plendl, seconded by Herbold to waive the 2nd reading of Policy 407.03 and 413.02. All in favor, motion passed. There was a discussion regarding Mr. Rob Wiese's resignation October 14, 2024 and him applying for the early retirement incentive package. Motion by Plendl, seconded by Motz to allow Mr. Rob Wiese to apply for the Early Retirement Incentive. Ayes included Plendl, Herbold, Motz and Bahl. Naye included Wilcox. Motion passed.

5. NEW BUSINESS

Discussion on current boilers in the new addition:

Two individuals addressed the Board on the status of the current boilers, Brandon Sitzmann, Kingsley Fire Chief and Greg Bell, Dunwell HVAC technician. Fire Chief Sitzmann addressed the Board with the dates of the CO2 calls to the school. Greg Bell addressed the Board on the boiler's service repairs and a recommendation for the purchase of new boilers.

New Boiler Quotes:

Motion by Motz, seconded by Herbold to approve the purchase of four boilers from CW Suter & Son for \$102,840. All in favor, motion passed. Current lead time on new boilers is 3-4 weeks out of the factory.
